FREYA Ambassadors Competition

Terms and Conditions

The FREYA Ambassadors' competition as detailed at [link] ("Competition") is operated by the FREYA Project [do we need do as a legal entity?), ("We" "Us" and "Our"). "You" and "Your" shall mean you, the person entering the Competition.

1 General

- 1.1 If You enter the Competition You are deemed to have agreed to abide by all of the following Terms and Conditions together with any amendments thereto (both of which are non-negotiable) under which the Competition is run, and to be bound by them. We may disqualify You without prior notice if You are in breach of any of these Terms and Conditions or any revised Terms and Conditions that We may from time to time impose.
- 1.2 We reserve the right to cancel the Competition at any stage if We deem this necessary or circumstances arise that are outside Our control.

2. Entries

- 2.1 The Competition is open to anyone who is has signed and returned a <u>FREYA Ambassador</u> <u>Agreement</u> to us before or at the time of submitting their competition entry, excluding:
- 2.1.1 employees or contractors of the FREYA Project partners
- 2.1.2 any person directly or indirectly involved in the running of the Competition, or their direct family members.
- 2.2 Entry is free. Only one entry will be accepted per person.
- 2.3 Applicants must be aged 18 years or older.
- 2.4 To enter the Competition, You must:
- 2.4.1 submit Your entry in accordance with the Competition brief at https://www.project-freya.eu/en/ambassadors/ambassador-programme;
- 2.4.2 ensure that Your entry is a true representation of your activities and impact as a FREYA Ambassador and does/do not in any way infringe or misappropriate the copyright or other intellectual property rights, or other rights of any third party;
- 2.4.3 accept these Terms and Conditions when you submit your entry.
- 2.5 All entries must be received submitting the application form to the FREYA email address by Wednesday 10 October, 6pm CEST. Any entries received after this will not be considered. We cannot be held responsible for:
- 2.5.1 ineligible or fraudulent entries; or
- 2.5.2 any lost or late entries, due to the Internet even where proof of submission can be provided.
- 2.6 We will select:
- 2.6.1 a shortlist of entries between Wednesday 10 October and Friday 19 October.

- 2.6.2 one winner. The winner will be contacted personally by email by Friday 18 October. The winner will be awarded the prize as detailed in the above Competition Details ("Prize"). The judges' decision shall be final, and no correspondence shall be entered into. Please see above Competition Details for more information.
- 2.7 The results of the Competition will be announced on Monday 28 October via Our website and social media.
- 2.8 The winner(s) accept(s) and agree that:
- 2.8.1 the Prize must be taken as stated, and cannot be deferred, exchanged or redeemed for its value;
- 2.8.2 no alternate to the Prize will be available; and
- 2.8.3. the Prize does not cover any costs incurred by the winner over and above those specified in the prize.

3. The Prize

- 3.1 The prize includes registration costs for the PIDapalooza festival to be held in Lisbon on 29-30 January 2020 for one person; reasonable travel from the winner's place of work or habitation to PIDapalooza and three nights' accommodation in Dublin, up to a maximum value of €1000 (one thousand Euros).
- 3.2 All travel and accommodation must be booked in agreement with the FREYA Ambassador Programme coordinators to ensure appropriate bookings.
- 3.3 Travel and accommodation costs above €1000 and subsistence costs must be covered by the winner or their employer.
- 3.4 The winner or their employer is responsible for procurement of travel insurance for the purposes of attending the PIDapalooza festival.

4. Rights and permissions

- 4.1 If We are unable to contact the winner after making reasonable efforts to do so, or the Prize is unclaimed after 1 month of Us notifying the winner then the Prize will be deemed to have been forfeited, and We reserve the right to offer the Prize to another entrant.
- 4.2 In the event that You are a winner, You agree to the following in relation to the Competition:
- 4.2.1 to participate in any publicity planned by the FREYA project, if required; and
- 4.2.2 to allow the posting of Your details on Our website;
- 4.2.3 that We may use any photographs supplied as part of Your entry for publicity/promotion purposes, at Our discretion; and
- 4.2.4 that the Prize will be awarded to You, subject to your availability to attend PIDapalooza either with the agreement of your employer or in your own personal time
- 4.2.5 that you have the funds to pay costs not covered by the Prize, or have agreement from your employer to cover such costs.

For the avoidance of doubt, in the event that the above requirements are not met, the Prize will be deemed to have been forfeited, and We reserve the right to offer the Prize to another entrant.

5. Personal Data

5.1 We will only use your email and contact details for the purposes of administering this Competition in accordance with the FREYA Ambassador Agreement, and will not publish them or provide them to anyone without Your permission.

6. Applicable Law

6.1 These Terms and Conditions shall be governed by and construed in accordance with English law. You hereby submit to and agree that the sole jurisdiction and venue for any actions that may arise under or in relation to the subject matter hereof shall be the English Courts.
